## Letter from the Chair

This newsletter will most likely find you in the midst of preparations for the AAG meetings in New Orleans, just a few weeks off. I would like to thank Steve Holloway and David Prytherch for organizing the specialty group sponsored sessions for the conference -- there are 45 in total! As you can read below, there is a fascinating range of sessions. There are a good number of 'blockbuster' sessions, each spanning the course of a day. Some sessions engage with New Orleans specifically: Mickey Lauria opens up the theme of urban education and community activism in New Orleans and there are four 'postcards' sessions, in which panelists bring with them varied impressions or interpretative snapshots of New Orleans. *Urban Geography* continues the project of drafting a history of the sub-discipline, with sessions this year on urban geography in the 1980s and 1990s. ## **Call For Papers**

### **Special Issue on The Geography of Finance and Financial Services, Scheduled Publication, Fall 2004**

While the importance of finance in regional economic development cannot be denied, geographers have largely avoided studying the industry. The reluctance to address the spatial aspects of finance has been attributed to a preoccupation with manufacturing firms as well as common assumptions of frictionless capital flows and efficient markets rendering space irrelevant to the industry. An emerging literature has begun to examine components of the financial space economy but the sub-discipline is only beginning its development. There remains a need to integrate research in the field into a coherent set of theories that will connect the geography of finance to the regional economic development process as well as economic geography.

In addition to providing a showcase for studies of contemporary spatial issues in finance, it is hoped that the special issue will serve to integrate, advance and illustrate the importance of the geography of finance to the discipline. Theoretically driven, empirical research on any aspect of finance, the financial industry or capital flows over space are requested. Topics may include (but are not limited to):

- \* Spatial impacts of industry deregulation
- \* Institutional forces behind capital flows
- \* Economic spillovers of financial institutions
- \* Information flows and finance
- \* Regional variations in municipal finance
- \* The spatial impacts of electronic currencies
- \* Regional variations in venture capital availability
- \* Stock options and regional development
- \* Emergence of the non-traditional finance industry
- \* Regional credit rationing
- \* The changing role of offshore financial centers
- \* The changing role of equity finance in knowledge economies

The Industrial Geographer is a new journal that focuses on a broad range of economic issues across all economic sectors and scales. The journal encourages submissions that are theoretically driven, empirical research. Please consult the journal web site at <http://igeographer.lib.indstate.edu> for author guidelines. Manuscripts should not exceed 5000 words. Research notes under 2500 words are also welcome. Please contact the guest editor before June 1st, 2003 if you are interested in contributing. Initial submissions must be received before January 15th, 2004. Publication of the special issue will be Fall 2004.
